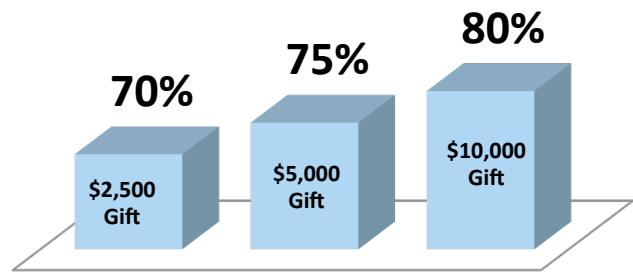
The Five Oaks Academy Annual Fund is grateful for gifts of any size and recognizes the following levels of giving:
